This is done by collecting survey data from the client, followed by an interview with the individual. Evaluations are available for youth and adults. Community Training

PARS staff are well versed in several topics and happy to offer training in our community. Most recently, our staff were trained on recognizing overdose symptoms and administering naloxone. Naloxone is an over-the-counter medication administered if an opioid overdose is suspected. We can provide this training to groups in our community through a generous grant from Kansas Fights Addiction. Kansas Fights Addiction is funded through opioid settlement funding.
